If you are a middle school youth or are in Confirmation at St John and would like to volunteer in any parish or school in the Archdiocese of Baltimore, you must complete the following steps:

- 1. Complete the attached "Worthy of the Call" application \*Please note that both child and parent must sign the application.
- 2. Have all 3 references filled out and returned with application

References must be 18 years old or older

- 1. Family friend/neighbor May NOT be a family member
- 2. Parent or Guardian
- 3. Teacher/Coach/Boss May NOT be a family member You may email, fax, mail, or drop it off to our office.
- 3. Attend a one hour "Worthy of Call" training video session
